I. Administrative Functions

- A. **Approval of Agenda:** Mr. Terrell made a motion to accept the agenda as presented. Dr. Chambers 2nd the motion and the agenda was unanimously approved.
- B. **Approval of Minutes**: Dr. Chambers made a motion to approve the June Board meeting minutes. Mr. Terrell 2nd the motion and the agenda was unanimously approved.

III. School Related Reports

A. Enrollment

- 1. Mr. Gassaway provided a registration update with the total number of fully enrolled students at 228.
- 2. Mr. Gassaway reported the school still has families providing paperwork and documentation and feels that these incoming students will help the school reach the goal of 240 students.
- B. **Curriculum**: Mr. Gassaway reported that the school has received most of the curriculum materials from the respective providers. He further reported that the school is awaiting set-up for some Chromebooks.

C. Facility

- 1. Mr. Gassaway reported that the school received a permit to serve breakfast and lunch to students from their providers.
- 2. Mr. Brewington reported that the school has a TCO but have qualified for the CO and are just awaiting the final paperwork.

D. Staffing-

- 1. **Current Staffing**: Mr. Gassaway reported that the only open staff positions for the school are two additional special education teachers.
- 2. Employer Relationship Structure and Retirement Plan Status and Structure: Ms. Dowd provided an overview and explanation of the 401K vs TRS options for current teachers and staff. Ms. Dowd explained Movement's decision to provide only the 401K option to teachers and staff.
- 3. **First Day of School and School Readiness**: Mr. Gassaway reported that the school is ready to welcome students in the building on August 1 for the first day of school.

IV. Consultant Report

- **A. Pre-Opening Status:** Mr. Brewington reported that from a commission standpoint, the school is in good pre-opening status.
- **B.** Current Needs: Mr. Brewington reviewed the following current needs:
 - 1. Revisions to the student handbook
 - 2. Awaiting the employee handbook from Insperity to compare with (and make possible edits to) the handbook previously approved
 - 3. Continued edits and revisions to the school safety plan
 - 4. All final policy and handbook drafts must be completed and approved prior to site monitoring.

- **D. Pre-Site Monitoring Preparation:**
 - 1. Mr. Brewington provided an overview of the site monitoring checklist.
